## **GENERAL TERMS & CONDITIONS**

Container Corporation of India Limited, Southern & South Central Region shall be auctioning uncleared/unclaimed Imported cargo brought into India, damaged domestic empty containers and Scrap items at respective terminals of CONCOR through Sealed E-tender cum online Auction sale/Sealed Tender as per the following terms and conditions. Subject to the reserve price, fixed by the **Container Corporation of India Limited** (hereinafter referred to as Container Corporation of India Limited) or persons duly authorized in this regard (hereinafter called authority) and of the terms & conditions contained herein all sale shall be made to the **highest bidder on AS IS WHERE IS BASIS and on NO COMPLAINT BASIS.**

### **1.0 Definitions:**

- 1.1 SELLER:** Seller referred in these conditions of sale, is Container Corporation of India Limited, Southern Region, 8<sup>th</sup> floor, EVR PeriyarSalai, CAO/CN Office, Southern Railway, Egmore, Chennai-600008 or Container Corporation of India Limited, South Central Region, No. 601-603, 6<sup>th</sup> Floor, Navketan Opp. Clock Tower, S.D. Road, Secunderbad-500 003 (Telangana) – hereinafter referred to as CONCOR.
- 1.2 AUCTIONEER:** Neelami (Hereinafter referred to as “Neelami”) is an e-commerce service provider appointed by the seller to facilitate online - auction. Neelami will only facilitate online e-tender cum online -auction and are considered as third Party not particularly interested in the item/s being sold on behalf of seller.
- 1.3 BIDDER:** Any person representing as an individual OR as proprietor OR as partner OR as an Authorized representative of any company and who is paying the caution money deposit as mentioned (E) above and registered with Neelami is considered as a bidder. One individual can represent as a bidder on his own behalf and on behalf of other companies provided he registers himself in those capacity separately i.e. for each representation he should pay separate stipulated caution money deposit.

### **2.0 PARTICIPATION**

- 2.1** The prospective bidder has to register with the auctioneer Neelami at the office address mentioned herein above. - 2.2** Bidder/Seller may note that any payments by DD/PO or any other means towards CMD or other purposes received by Neelami on behalf of Bidder/ Seller shall be handled in good faith and intention. However, Neelami shall not be responsible for the loss of the DD/ PO from its custody due to reasons beyond its control such as fire, theft, burglary, loss in transit, accident, war, riots, civil commotion, any terrorist activity, any natural calamity, adverse weather, climatic conditions etc.

**Prospective Bidders may please note that failure to submit the Auction Registration form duly filled and signed along with the prescribed documents will lead to non-activation of the User ID even if the prescribed CMD has been remitted.**

- 2.3 On payment of CMD/ DD along with duly filled and signed Auction Registration Form on Bidder's Company letter head, Neelami will activate the User- ID to enter into Auction Room on their website [www.neelami.co.in](http://www.neelami.co.in).
- 2.4 All the bidders participating in online auction should mention their valid VAT/TIN/ GST Registration Number in Auction Registration Form. - 2.6 Bidders SHOULD NOT disclose their PASSWORD to anyone and safeguard its secrecy. Bidders are advised to change the Password. Refer the "Steps of Actual Bidding Procedure.
- 2.7 The minimum bid price, if any i.e. base price will be displayed against each lot on the bidding screen of all participating bidders. The software will not accept any bid lower than the minimum bid price.
- 2.8 **Sealed Tender Process:**

  - e. **Sealed bids without Earnest Money Deposit or Caution Money Deposit submitted by Cheque/cash shall be summarily rejected.**
  - f. Container Corporation of India Limited shall not be responsible for delay, loss or non-receipt of tenders documents sent by post either way.

- 2.10 CMD/ EMD amount will not carry interest.
- 2.11 The highest bidder does not get any right to demand acceptance of his offer. Seller reserves the right to accept/ reject/ cancel any bid, withdraw any Lot at any stage from Auction even after acceptance of bid/ issue of delivery order or release order. Seller shall not be responsible for any damages/ loss whatsoever to the successful bidder on account of such withdrawal.
- 2.12 In the event of failure on the part of the successful bidder to fulfill his contractual obligations Seller/ Neelami reserves the right to debar such bidder from participating in any future auction conducted by Neelami on behalf of seller.

- 3.3 All the consignments will be sold on LOT BASIS. Lots listed under the Special Instructions are sold subject to compliance of certain statutory conditions/ clearances listed against the Lot Numbers. The expenses towards obtaining of such clearances are to be borne by the successful bidders.

- 5.1 **Provisional online auction cum e-tender/Sealed Tender result will be displayed on Neelami website on 26-11-2018 or later.** The highest bid will only be provisionally accepted on Subject to Confirmation (STC) basis and so also the direct confirmation and the highest bidder does not get any right to demand acceptance of his offer.
