

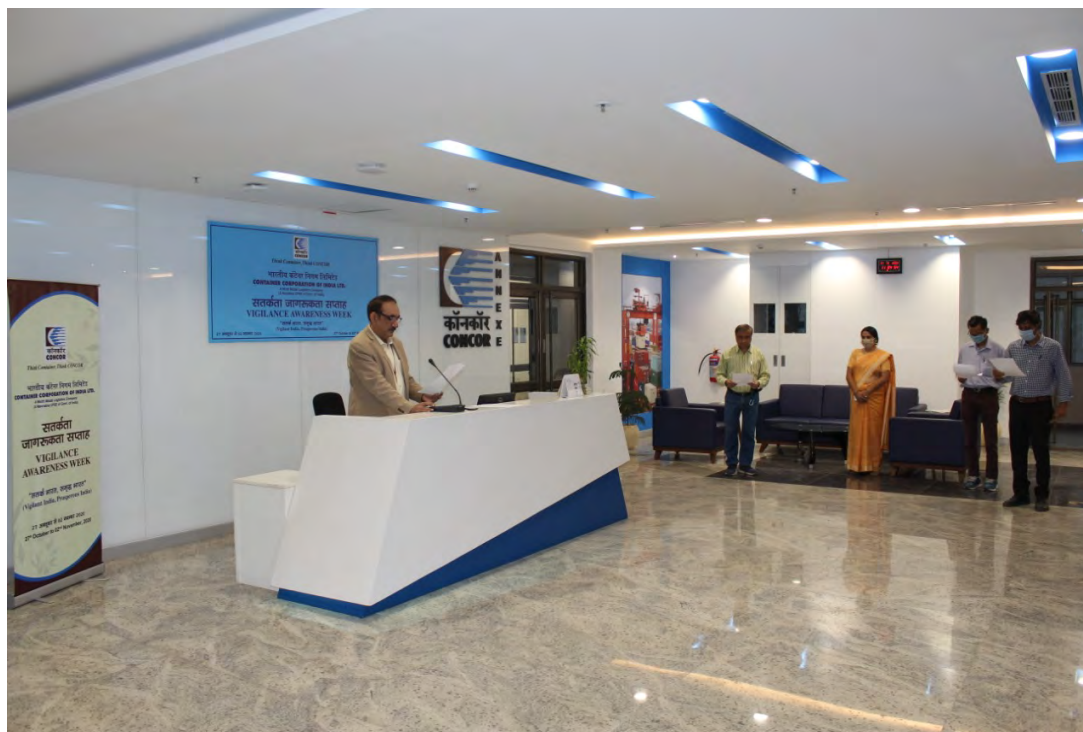
## Observance of Vigilance Awareness Week (VAW) – 2020

Container Corporation of India Ltd. (CONCOR) , a Navratna PSU under Ministry of Railways engaged in the business of providing logistics solutions to the customers for International as well as Domestic trade, observed Vigilance Awareness Week (VAW) at all its offices including subsidiary companies from 27<sup>th</sup> October, 2020 to 2<sup>nd</sup> November, 2020 with great enthusiasm and zeal. The theme of the Vigilance Awareness Week this year was “**Vigilant India, Prosperous India (Satark Bharat, Samriddh Bharat)**”.

The following activities were undertaken during the Vigilance Awareness Week-2020:
