This has reference to tender notice no. CON/IT/1261/20/01 published on 13/07/2020.

Prospective bidders may kindly note that in the above mentioned tender document, the following Amendments have been made :

Clause No. 5 of NIT	In terms of orders for Public Procurement (Performance to Make in India) the minimum local content shall be 50%, margin of purchase preference shall be 20%. Clause 16.2 of Section-III	If L1 is not from a local supplier, the lowest bidder among the local suppliers, will be invited to match the L1 price subject to local supplier's quoted prices falling within the margin of purchase preference (L1+20%), and the contract shall be awarded to such local supplier subject to matching the L1 price.	If L1 is not <u>Class-I local supplier</u> , the lowest bidder among the <u>Class-I local supplier</u> , will be invited to match the L1 price subject to <u>Class-I local supplier's</u> quoted prices falling within the margin of purchase preference (L1+20%), and the contract shall be awarded to such <u>Class-I local supplier</u> subject to matching the L1 price.
Clause 16.3 of Section-III	In case such lowest eligible local supplier fails to match the L1 price, the local supplier with the next higher bid within the margin of purchase preference (L1+20%) shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the local suppliers within the margin of purchase preference matches the L1 price, then the contract may be awarded to the L1 bidder.	In case such lowest eligible <u>Class-I local supplier</u> fails to match the L1 price, the <u>Class-I local supplier</u> with the next higher bid within the margin of purchase preference (L1+20%) shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the <u>Class-I local suppliers</u> within the margin of purchase preference matches the L1 price, then the contract may be awarded to the L1 bidder.

Clause 16.4 of Section-III	The local supplier shall be required to provide a certificate (self-certification as per the enclose-II supported by CA if the estimate cost of tender is <Rs. 10 Crore and if the estimate cost of Tender is >Rs. 10 Crore certificate from the statutory auditor or cost auditor of the company) stating that "the item offered meets the minimum local content and shall give details of the location(s) at which the local value addition is made".	The ' <u>Class-I local supplier</u> '/ ' <u>Class-II local supplier</u> ' shall be required to indicate percentage of local content and provide self certification that the item offered meets the local content and shall give details of the location(s) at which the local value addition is made.  In case of procurement for a value in excess of Rs. 10 Crores, the ' <u>Class-I local supplier</u> '/ ' <u>Class-II local supplier</u> ' shall be required to provide a certificate from the statutory auditor or cost auditor of the company (in the case of companies) or from a practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
New Clause 16.5 of Section-III	--	Only ' <u>Class-I local supplier</u> ' and ' <u>Class-II local supplier</u> ', as defined under the order, shall be eligible to bid in procurements undertaken by procuring entities, except when Global tender enquiry has been issued
