Bidders have to pay the Tender Processing Fee to ITI through e-payment at the time of submission of bid.

- (v) In case MSEs do not provide the above mentioned document, their offer will not be entertained.
- (vi) The MSEs must also indicate the terminal validity date of their registration (except UAM). In those cases where the MSEs are not able to provide the certificate with validity date of their registration, a self-declaration by the MSE (Party) on their letter head, confirming the validity of their registration can be accepted.

Note 2: Startup

- (i) The Start up are exempted from submission of EMD.
 - (ii) For availing the relaxation, bidder is required to submit requisite certificate towards Startup enterprise registration issued by Department of Industrial Policy and Promotion (DIPP), Ministry of Commerce and the Certificate duly self attested/notary public with legible stamp.
