In those cases where the MSEs are not able to provide the certificate with validity date of their registration, a self-declaration by the MSE (Party) on their letter head, confirming the validity of their registration can be accepted.

Note 2: Startup

- (i) The Start up are exempted from submission of EMD.
 - (ii) For availing the relaxation, bidder is required to submit requisite certificate towards Startup enterprise registration issued by Department of Industrial Policy and Promotion (DIPP), Ministry of Commerce and the Certificate duly self attested/notary public with legible stamp.
