GENERAL TERMS & CONDITIONS OF SALE

- 1. **SELLER** Seller referred in these conditions of sale, is the Department of Customs through their officers AND/OR the Custodian, Container Corporation of India Ltd. (hereinafter referred to as CONCOR) All Payments (except applicable service charges which is to be paid to MSCT LTD.) are to be drawn in favour of the Custodian i.e. **Container Corporation of India Ltd.**
- **2. AUCTIONEER** is an agency appointed as an auctioneer to facilitate E-Tender cum Online auction on Internet by the Custodian. They are expected to facilitate organising and conducting an auction and are considered as third party not particularly interested in the item being sold for and on behalf of the Container Corporation of India Ltd.
- **3. BIDDER** Any person representing as an individual OR as proprietor OR as a partner OR as an authorised representative of any company and who is paying the Earnest Money Deposit (EMD) and getting registered with MSTC Ltd. is considered as a registered bidder. One individual can represent as a bidder on his own behalf or on behalf of his company. But the bidder cannot register separately for self & company at the same time. Bidder must read the terms and conditions of the auction sale very carefully and then only place his bid in the e auction.
- 4. All Contracts/Transactions entered into by the BUYER/BIDDER Arising out of this E-Auction cum E-Tender shall be governed by the Integrity Pact available on www.concorindia.com and www.mstcindia.co.in.

- iii. The prospective bidder shall have to deposit Pre-Bid Earnest Money Deposit (EMD) of Individual EMD as mentioned against individual lot of the above locations, in the office of MSTC Ltd.
- iv. EMD of unsuccessful bidders will be returned by M/s MSTC Ltd. to the bidder.



6.EMD Forfeiture

Bidder participating for all lots has to make the balance payment & take delivery of all the lots allotted to him. In case for any of allotted lot, bidder doesn't take delivery of lot with in the stipulated time or the time extended by CONCOR the EMD and balance payment made for that particular lot will be forfeited . In case bidder is participating for more than one lot & becomes successful bidder for one or more lot, the EMD of unsuccessful lots will not be adjusted. In case bidder fails to make the balance due payment within the stipulated time or the time extended by CONCOR then EMD paid for the particular lot will be forfeited.

MSTC shall submit complete pre-bid EMD amount of successful bidders to the CONCOR.

In the event of any dispute with regard to non-lifting / non – availability of inspected material etc. and forfeiture of EMD, MSTC Ltd. will not be held responsible for the loss / forfeiture and purchaser shall keep MSTC Ltd. fully indemnified and harmless against any claim and proceedings of any of their own or against the employees or others.

EMD of unsuccessful bidders (other than H-1 bidders) shall be returned directly by MSTC.

CONDITIONS OF SALE

- **7.** The sale is through e-Tender-Cum-E-Auction method. In case of e-Tender interested buyer can submit their bid through e-tender only once. Buyer may refer to 'Bidder's Manual' for instructions on bidding process in e-auction/e-tender.
- 8. Goods are being sold on 'AS IS and WHERE IS and WHATEVER IT IS BASIS' and "NO COMPLAINT BASIS".
- 9. All the E-Auction/E-tender Lots are subject to "Reserve Price" fixed by seller's i.e. Container Corporation of India Ltd. The highest bid for each lot shall be subject to confirmation by the Seller and in case of EXIM cargo by confirmation by Customs. Management of Container Corporation of India Ltd. reserves the right to accept or reject any offer for any reason whatsoever or even without assigning any reason. In the event of any dispute at last or highest bid, the same shall be resolved by Container Corporation of India Ltd. And if need be the particular lot/ lots in question may be re-auctioned. The special conditions applicable for specific lots have been mentioned against respective lots in annexure.
- **10.** The lot or lots shall be removed in full from the site with whatever faults and flaws in description or otherwise and no selection or sorting of the material will be allowed. Quantities, Quality, sizes, measurements, numbers and cargo weights stated are approximate. Weighment of auction lots will not be permitted. Bidders are not allowed to take the sample from the lot.
- **11.** Container Corporation of India Ltd. / MSTC Ltd. does not give warrantee or guarantee of the Quantity, Quality, and Chemical composition etc. of each individual item in the lot or about the "End Use" or fitness for a particular purpose.



- **12.** Goods are sold on the assumptions that the bidder has inspected the lot prior to bidding and know what he is bidding for. No complaint shall be entertained after the lot is allotted.
- **13.** Goods may be sold singly or by clubbing them in lots as suitable, convenient and advantageous in opinion the of Container Corporation of India Ltd. Lot will be put up for auction as per convenience of management of Container Corporation of India Ltd. & it is not obligatory to go serially.
- **14.** During Inspection of lots, it may be clearly understood that the quality of the material inside the container/ boxes/ cartons/ bales/ cases/packages/bags etc. may not necessarily be of exact quality, quantity, weight, size, dimensions, specifications, features etc. The bidders are given sufficient time for inspection to inspect the quality and quantity of goods before auction. No complaints with respect to quality and quantity of goods entertained after auction is over. No complaint of variation in the cargo details shall be accepted later at the time of delivery.
- **15.** Any lot or part thereof may be withdrawn from the sale at any time before it is actually physically delivered out of the campus without disclosing any reasons for such withdrawal. However, if any payment has been made it would be refunded without Interest.
- **16.** MSTC Ltd. runs its business on the basis of a robust Website. - 17. The Sale will be governed by the Material List & Special Terms & Conditions(STC) displayed on the Live e-Auction Floor (and not under Forthcoming Auctions) as well as General Terms & Conditions (GTC) and Buyer Specific Terms & Conditions (BSTC) already accepted by the Bidder at the time of e - Auction Registration with MSTC. The Material List & STC displayed under View Forthcoming Auctions on MSTC's e-Auction Website are tentative and subject to change at MSTC's sole discretion before the start of e-Auction. - 18. MSTC Ltd. /CONCOR takes no responsibility of the quality, quantity, documentation details of Buyers/sellers. Both the buyers & sellers agree to defend indemnity and hold MSTC Ltd. /CONCOR harmless from any loss, damage, cost and expenses caused by any reason during this transaction. In no event shall MSTC Ltd. /CONCOR be liable for any loss for the transactions by business, revenues, profit, costs direct and incidental, consequential or punitive damages of any claim. Both the parties agree to have discussed all the related matter regarding this transaction and have understood in full that MSTC Ltd. /CONCOR has provided a source of supply and has nothing to do any further especially with regards to quality, warranty, guarantees, delivery schedules,

MSTC Ltd. is only an e-commerce service provider, and cannot be party to or control in any manner any transactions between the Seller and Bidder. MSTC Ltd. shall neither be responsible nor liable to mediate or resolve any disputes or disagreements between the Seller and Bidder.

19. The Seller/Bidder agrees to limit the liability of MSTC Ltd. for any and all claims, losses, costs, damages of any nature whatsoever or claims expenses from any cause or causes, including attorneys' fees and costs, so that the total aggregate liability of MSTC Ltd. to the Seller/Bidder shall not exceed its total fee receivable from the Seller/Bidder. It is intended that this limitation apply to any and all liability or cause of action however alleged or arising, unless otherwise prohibited by law.

ANNOUNCEMENTS

20. Announcements during the auction including announcement of additional conditions OR correction in the catalogue and/or additions or deletions of items being offered for sale are being done with the consent and knowledge of the Container Corporation of India Ltd and it will be binding on the bidder.

LOT CONFIRMATION.

21. All the lots are sold on Subject to Approval Basis (STA).

For EXIM: CONCOR will provide provisional confirmation to MSTC via email. However, final confirmation of lots from CONCOR on MSTC platform shall be done only after approval from Custom. In case bid is rejected by Customs the EMD deposited for that lot will be refunded to the bidder WITHOUT INTEREST.

For Non-EXIM/Domestic: Concerned confirmation by CONCOR on MSTC shall be full and final.

22. For all the lots confirmation will be informed to the bidder on approval of EXIM lots by concerned Customs department, via E-Mail by MSTC **subsequent to the confirmation received from CONCOR.**

VALIDITY

23. The Online auction bidders and Tender bidders must keep their bids valid for a period of **180 days (One Hundred and Eighty Days)** from the date of closing of e-Auction excluding the date of closing. In case the 180th day falls on a holiday or remains closed for CONCOR, such Bids will be deemed to be automatically extended to be valid up to the next working day of CONCOR. (Depending on approval of bid by Customs)

In case the bids are not confirmed by CONCOR within 180 days, bidders have option to take refund of EMD / Security without Interest.



24. Bids: All bids placed are legally valid bids and are to be considered as bids from the bidder himself. Once the bid is placed, the Bidders cannot reduce or withdraw or cancel the bid for whatever reason and no communication will be accepted. If done so, the seller will forfeit the EMD. The highest and the latest bid on the Auction shall supersede all the previous bids of the bidder. Bidders may please note that in the event of a manual bid amount matching that of Maximum limit of auto-bid, the manual bid will prevail and be considered. Bidders may please also note that in the event of a tender bid amount matching that of e-auction bid amount, the tender bid will prevail and be considered. The bidder with the highest offer/ bid does not get any right to demand acceptance of his Bid.

PAYMENT

- **25.** On provisional confirmation from MSTC bidders are required to pay 25% of the bid amount within the 07 (Seven) days of confirmation to MSTC. Details of this will be provided by the MSTC and MSTC will transfer this amount to CONCOR immediately.
- **26. Final Payment:** After final confirmation MSTC will issue the Acceptance letter and bidder need to deposit balance payment of each lot of materials along with applicable GST and other relevant taxes to CONCOR directly in one instalment within 10 days from the date of Acceptance Letter (on mail) issued by MSTC (including the date of issuance of such letter).
- **27.** In case where NOC from any Government Agency / Department has to be obtained either by Bidder or by CONCOR then the payment period will begin from the date on which such a NOC has been issued by the concerned agency.
- **28.** In case the date of submission of payment happens to fall on a Public Holiday, the next day shall be considered as the date of submission of payment. DDs of Cooperative Bank shall not be accepted and will be returned without any action being taken on them.
- **29.** Payment towards material value and other dues is to be made as stipulated in Sale Order/Acceptance letter. If there is a default in payment as per Terms of the Sale order cum Acceptance letter, the Security deposit mentioned therein will stand forfeited automatically without any further notice and Sale Order will stand cancelled. CONCOR will re-auction the lot accordingly.
- **30. LATE PAYMENT PENALTY:** For Any delay in making payment within time limit specified, the due payment may be made together with late payment penalty @ 1% per week or part thereof on the entire bid value to CONCOR.
- **31.** It is to be noted that payment with late penalty charges is accepted only upto 14 calendar days after expiry of allowed time for payment.
- **32.** In case the bidder does not submit the payment in time with penalty, sale of the concern lot will be automatically cancelled and the Earnest Money/Security Deposit (as the case may be) will automatically stand forfeited.
- **33.** Auction Sale Invoice will be issued by respective location to which the lot pertains. Bidder has to make all the balance payment as applicable in case of destuffed deliveries as per EXIM Tariff /Domestic Tariff as the location may be along with all applicable taxes & statutory levies, Container destuffing charges,



Cargo loading charges, etc. as applicable at the concerned location at the time of physical delivery of cargo. The balance payment will be accepted by way of Pay Order/Demand Draft drawn on any Scheduled / Nationalised bank drawn/e-payment in favour of "Container Corporation of India Ltd." payable at Ahmedabad.

- **34.** In case a NOC required for any lot from regulatory bodies or Government Agencies for confirming the sale and NOC is refused, the EMD deposited for that lot will be refunded to the bidder WITHOUT INTEREST by CONCOR.
- **35.** If no Intimation reaches for reasons beyond our control the Buyers are expected to take efforts to find out status before the last day. Non-receipts of Intimation should not be an excuse for non-payment.
- **36.** If the purchaser fails to make payment and/or take delivery of the material, Container Corporation of India Ltd shall have the right to auction the undelivered material immediately in the next auction without any intimation to the successful bidder and the **EMD amount** along with balance payment made (i.e. including Handling Charges GST etc.) deposited by the bidder shall be forfeited.

INCIDENTAL/ OTHER COSTS

37. The cost of material handling i.e., loading charges along with all applicable taxes and statutory levies that are applicable at the time of physical delivery of cargo, shall be borne by the bidder and payment has to be made to Container Corporation of India Ltd. at the rate prevailing at the time of taking delivery at the respective terminal. Prevailing tariff for handling for each lot etc. may be understood from the terminal during the inspection period.

TAXES

- **38.** All bids invited are for the net amount accruable to Container Corporation of India Ltd. and relevant taxes, levies, etc. except Customs Duty shall be payable by the bidder and these taxes shall be treated as extra and are expected to be paid as per payment schedule before taking delivery.
- **39.** It is expressly made clear that, all the taxes/ statutory levies etc. shall be borne by the bidder before taking the delivery of the lots.

DELIVERY

- **40.** Bidders/ Tenders will not be allowed to admit any other person or assign, or sublet in any manner, the interest in the contract, after getting the offer.
- **41.** On receipt of full payment by CONCOR and service charge by M/s MSTC Ltd, CONCOR will issue final Delivery Order from Ahmedabad Cluster Office.
- **42.** Customers are required to present Original Delivery Order issued by CONCOR at the time of Delivery.
- **43.** The successful bidders shall lift the specified material lying in the lot allotted to them by their own transport at their own cost within 15 Days (Fifteen Days) from the date of Delivery order issued by CONCOR (excluding date of issuance of Delivery order). On the basis of delivery order, CONCOR will issue gate pass for the particular lot. If last day of delivery falls on a public holiday, the next working day shall be considered as the last date of lifting.



- **44.** Customers are required to lift the material completely with whatever faults and flaws in description or otherwise and without any selection or sorting of the material and on clean sweep basis as to clear site/ container within the specified time limit, failing which TSC will be charged from bidder @ Rs 500/-per TEU per day (irrespective of lot size) up to maximum 30 days along with GST or other relevant taxes.
- **45.** If bidder does not lift the cargo even after expiry of 30 days grace time (excl. 15 days free time), the sale stand cancelled & all the payment made by bidder/buyer shall be forfeited without any further notice to bidder and subsequently material /cargo will be re-auctioned.
- **46.** In case of cargo store in warehouse or open space, wharfage shall be charged as per public tariff rate at concern terminal.
- **47.** Such TSC shall directly be deposited to CONCOR by bidder either through online mode or bank Draft.
- **48.** The goods shall be lying in the premises after the conclusion of the bidding at the sole risk and cost of the purchaser in all respect and the purchaser should take the delivery at his own expenses at the earliest and in any case not later than the period prescribed above.
- **49.** Delivery of goods will commence from the date decided by CONCOR which will be intimated through e-mail by CONCOR i.e. the next working days after issuance of Delivery order/ intimation letter and it would be effected during normal working hours only. All loading must be completed within the normal working hours as prescribed by respective terminal.
- **50.** The successful bidder shall produce the Original Delivery Order issued by Container Corporation of India Ltd. at the concerned terminal, for proper identification of bidder at the time of taking delivery of the material. It is therefore, the responsibility of the bidder to keep the documents in safe custody. The person who has collected the material from Container Corporation of India Ltd. by producing the Original Delivery Order issued, if subsequently found to be illegal possessor / producer of the documents Container Corporation of India Ltd. shall in NO WAY be responsible.
- **51.** Container Corporation of India Ltd. will not be in any way responsible for failure to deliver the goods as per delivery schedule due to causes beyond their control such as change in Govt. Policy, strikes, lockouts, cessation of labour, shortened hours, act of God or other causes or contingency whatsoever. The bidder shall not be entitled to cancel the contract & the period of delivery shall automatically be extended accordingly.
