

Subject: Quotation for Procurement of 600 nos. of Plastic Pallets.

We desire to procure 600 nos. of Plastic Pallets as per the Specifications given here below for material handling at FHEL's CA Store, HSIIDC Industrial Estate, Rai, Sonipat. You are requested to give your lowest offer for subject items as per following scope of supply and terms & conditions.

1. **Scope of Supply:** 600 nos. of Plastic Pallets suitable for Forklift / Power and Hand Pallets (suitable for temperature ranging from -2⁰ Centigrade to ambient).

2. **Specifications:**

3. **Terms & Conditions:**

- a. Rates to be quoted FOR; FHEL, Rai, Sonipat and it should be all inclusive, however, the breakup for tax etc to be given.
- b. 90% Payment will be made within 30 days from the date of supply subject to submission of accurate invoice along with delivery challans, proof of GST amount deposited, Test Report from a Govt./Govt. approved lab for parameters specified here above and acceptance report from FHEL officer, and balance 10% will be made after completion of warranty obligation or on submission of performance security Bank Guarantee of 10% of the contract value from a scheduled Bank. The BG should be valid till the completion of warranty obligation as per the contract. ADVANCE WILL NOT BE GIVEN.
- c. Warranty Period: This warranty shall remain valid for 12 months from date of Receipt at FHEL CA Store.
- d. Delivery of material to be given within 10 days at FHEL site at HSIIDC, Rai, Sonipat (Haryana).

- e. **Liquidated Damages:** If the Parties fails to supply of subject items within the time delivery period or as per the schedule issued, FHEL shall deduct from the Contract price as liquidated damages, a sum equivalent to 1% of the cost of undelivered quantity for each week or part there of up to a maximum deduction of 10% (Ten percent) of undelivered quantity (exclusive of taxes and duties). Once the maximum is reached FHEL may consider termination of the contract.
- f. The bid is to be enclosed in single envelope. Enquiry documents signed and stamped on all pages as unconditional acceptance of Enquiry document Scope of work, Terms & conditions.
- g. "This notice is being published for information only and is not an open invitation to quote in this limited tender/quotation. Participation in this tender/quotation is by invitation only and is limited to the selected FHEL enlisted contractors. Unsolicited offers are liable to be ignored. However, contractors who desire to participate in such tenders/quotations in future may apply for enlistment with FHEL as per procedure".
- h. Arithmetic errors will be rectified on the following basis:
- "If there is a discrepancy between the unit price and the total price, which is obtained by multiplying the unit price with quantity, the unit price shall prevail and the total price shall be corrected."
 - "If there is a discrepancy between rates in words and figures, the rates in words shall prevail."
 - "If the Supplier does not accept the correction of errors, his bid will be rejected."
