- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The bidder has to use his own experience and judgment to consider all the required reso urces and the offer must be submitted accordingly. The bidders are advised to visit the loca tion CONCOR, Inland Container Depot, Kanpur (Uttar Pradesh) and go through the attached scope of work before submitting the bid.
- 2. Area mentioned may increase or decrease during the currency of the contract.
- 3. If the existing Contractor of CONCOR has submitted the tender for the same activity in the same facility, the existing contractors bid should necessarily be accompanied by a satisfactory performance report from the same terminal.
- 4. In case the bidder is working at any or one of CONCOR terminals in the same Area (Area -I/ North), his bid should necessarily be accompanied by a satisfactory performance report f rom that/those terminal/s. In case, his bid is not accompanied with the above-mentioned sa tisfactory performance report, it will not be considered.

- 5. **Shramik Kalyan Portal Clause:** Contractor is to abide by the provisions of Payment of Wages Act & Minimum Wages Act in terms of clause 54 and 55 of Indian Railways General Condition of Contract. In order to ensure the same, an application has been developed and hosted on website 'www.shramikkalyan.indianrailways.gov.in'. Contractor shall regist er his firm/company etc. and upload requisite details of labour and their payment in this po rtal. These details shall be available in public domain. The Registration/updation of Portal shall be done as under:-
 - (i) Contractor shall apply for onetime registration of his company/firm etc. in the Shramik kalyan portal with requisite details subsequent to issue of Letter of Acceptance (LOI). Aut horised representative of CONCOR shall approve the contractor's registration on the port al within 7 days of receipt of such request.
 - (ii) Contractor once approved by any authorised representative of CONCOR, can create p assword with login ID (PAN No.) for subsequent use of portal for all LoAs issued in his favo r.
 - (iii) The contractor once registered on the portal, shall provide details of his Letter Of Acc eptances (LOA), Contract Agreements on shramikkalyan portal within 15 days of issue of any LOA for approval of authorised representative of CONCOR. The Authorised represent ative of CONCOR shall update (if required) and approve the details of LOA filled by contractor within 7 days of receipt of such request.
 - (iv) After approval of LOA by the authorised representative of CONCOR, contractor shall f ill the salient details of contract labours engaged in the contract and ensure updating of each wage payment to them on **Shramikkalyan portal** on monthly basis.
 - (v) It shall be mandatory upon the contractor to ensure correct and prompt uploading of all salient details of engaged contractual labour and payments made thereof after each wage period.

6. For Micro and Small Enterprises (MSEs):

- (i) MSEs who are interested in availing the benefits will enclose with their offer the proof of their being MSE registered (for tendered item) with any of the agencies mentioned in the notification of Ministry of MSME.
- (ii) The MSEs should submit Udyam Registration Certificate along with the Bid and registration certificate should be valid at the time of opening of Bid.
- (iii) Eligible MSEs are exempted from cost of tender document (where applicable) and Earnest Money Deposit (EMD).

- (iv) Failing to fulfil the conditions as per (a) and/or (b) above, such offers will not be liable for consideration of MSE benefits and shall be liable for rejection.
- (v) "CONCOR is registered with TReDS Platform of RXIL (Receivables Exchange of India Ltd.) having Buyer registration Number "CO0000642". The URL for RXIL Platform is "https://www.rxil.in". MSE suppliers/vendors are required to register themselves on RXIL Platform for availing the facility of bill discounting on TReDS portal. The URL for onboarding is "https://onboarding.rxil.in/customerapp/home".
- (vi) MSE Vendor will bear all costs relating to availing the facility of discounting on TReD S

platform including but not limited to Registration charges, Transaction charges for financing, Discounting Charges, Interest on financing, or any other charges known by an y

name shall be borne by MSE Vendor.

(vii) MSE Vendor hereby agrees to indemnify, hold harmless and keep CONCOR and its affiliates, Directors, officers, representatives, agents and employees indemnified, from a ny

and all damages, losses, claims and liabilities (including legal costs) which may arise from

Sellers submission, posting or display, participation, in any manner, on the TReDS Platform or from the use of Services or from the Buyer's breach of any of the terms and conditions of the Usage Terms or of this Agreement and any Applicable Law on a full indemnitybasis.

(viii) CONCOR shall not be liable for any special, indirect, punitive, incidental or consequential damages or any damages whatsoever (including but not limited to damages for loss of profits or savings, business interruption, loss of information), whether in contract, tort, equity or otherwise or any other damages resulting from using TReDS platform for discounting their (MSE Vendor's) invoices.

7. Time limit for submission of bills:

- (i) The contractor shall make a claim for the services rendered under this contract to CO NCOR within Four months of such service. If he does not prefer claim within the said peri od he shall be deemed to have waived his right in the respect thereof and shall not be en titled to any payment on account thereof. Nevertheless, the Accepting Authority on writt en request can waive off this limitation and allow late submission of bills if the reasons for delay are found convincing and reasonable.
 - (ii) No claim in respect of under payment to the contractor shall be considered valid or e ntertained unless a claim in writing is made thereof within (4) four months from the date on which payment of the original claim thereto was made. Any claim for such under pay ment not received within stipulated four months period, shall be liable to be summarily r ejected by CONCOR. Nevertheless, the Accepting Authority on written request can waive off this limitation and allow late submission of bills if the reasons for delay are found con vincing and reasonable.
 - (iii) However, in case of any specific issue over which the contractor had not billed for an y particular activity, the same can be allowed for payment, subject to the prior approval of Tender Accepting Authority, notwithstanding what has been laid down in the Clause on Payment. The decision of the Tender Accepting Authority shall be final and binding on

the contractor.

8. <u>Unsatisfactory Performance, Penalty and Consequences Thereof:</u>

- CONCOR shall impose penalty upto Rs.5000/- per instance in case of non-compliance of i nstruction/work under this contract as stipulated in the tender.
- i) The contractor shall at all times ensure that his performance is satisfactory, failing whi ch CONCOR shall be at the liberty to get the affected work done by another agency, at the risk and cost of the contractor. In such cases, CONCOR shall be at liberty to carry on the work under this agreement through any other agency directly for the work and all expenses incurred on this account shall be at the sole risk and responsibility of the contractor and shall be recovered from any money due to him or from his security deposit.
- ii) The certificate of the CONCOR official in-charge as to the sum payable to the contracto r, if the work in question had been carried out by him under terms of the contract, shall be final and binding on the contractor.
- iii) If the extra expenditure incurred is more than the performance Security Deposit prop osed to be forfeited, the expenditure over and in excess of the security deposit may be r ecovered by deducting the said amount from any pending bills of the contractor under th is or any other of his contract with CONCOR anywhere in India or otherwise. The contract or shall have no claim whatsoever against CONCOR in consequence of the termination of contract as stated above.

9. Termination of contract

- i) In the event of repeated instances of unsatisfactory service or any failure at any time on the part of the contractor to comply with the terms and provisions of this contract to the satisfaction of CONCOR (who shall be the sole judge and whose decision shall be final), it shall be open to CONCOR to terminate this contract by giving not less than (7) seven days' notice in writing to that effect and if the contractor, does not make good his default within the notice period, CONCOR shall be entitled to terminate the contract as a whole or in part.
- ii) In the event of such termination of the contract, CONCOR shall be entitled to forfeit the security deposit as it may consider fit.
- iii) If the extra expenditure incurred by CONCOR on account of unsatisfactory performan ce of the contractor as mentioned in paragraphs above is more than the Security Deposit proposed to be forfeited, the expenditure over and in excess of the Security Deposit may be recovered by deducting the said amount from pending bills of the contractor under this stender or from money due to the contractor by CONCOR under this or any other contract or otherwise. The contractor shall have no claim whatsoever against CONCOR, in consequence on such recoveries or termination of the contract, as stated above.
- iv) The certificate of CONCOR Official Incharge of the terminal, as to the sum payable to t he new agency, if the work in question had been carried out by him under the terms of c ontract, shall be final and binding on the contractor.
- v) If at any time the contractor becomes insolvent or files an application for insolvency or any creditor of his moves the court for adjudicating him as an insolvent or, if he is convicted by any court of law, CONCOR will have the absolute option of terminating the contract forthwith and he shall have no right for damages or compensations on this account.
- vi) In the contract which has been rescinded as a whole, the Security Deposit already wit

h CONCOR under the contract shall be encashed/forfeited and the Performance/Bank Gu arantee already submitted for the contract shall be encashed. The balance work shall be got done independently without risk & cost of the failed Contractor. The failed Contractor shall be debarred from participating in the tender for executing the balance work.

10. Arbitration Clause:

In the event of any question, dispute or differences arising under these conditions or in c onnection with this contract, the same shall be referred to Delhi International Arbitration Centre. The parties to the agreement agreed to resolve their disputes and differences in accordance with the Delhi International Arbitration Centre (Arbitration proceedings) Rule s and to have the Centre as appointing Authority. The decision of the centre shall be bin ding on both parties. The parties shall be governed by the law in force in India and the di spute shall be resolved by the law applicable in India. The parties hereby agreed that the language used in the arbitration proceedings shall be English. Rest of the terms is subject to agreement between the parties. The Arbitrator may from time to time with the consent of all the parties to the contract extend the time for making the award. Subject as aforesaid, the Arbitration and Conciliation Act, 1996 and its amendments and the rules the here under for the time being in force shall be deemed to apply for the arbitration proceedings under this clause. The Venue of the arbitration shall be at New Delhi.

In case of any disputes or differences between the parties hereto, the Civil Courts of Del hi shall have exclusive jurisdiction for the implementation of tender.

11. Service during post contract period

It will be obligatory on the part of contractor to continue to work on the same rates, term s and conditions prevailing on the last date of the contract even beyond contract period for (4) four months or till alternate arrangements are made, whichever is earlier.

12. Interpretation of the Clause
