As such, **GST** shall be applicable on CONCOR works and *shall not be* reimbursed by CONCOR. **The details regarding applicability of GST is available at clause 13.2 of "Instructions to Tenderers"**. Therefore, tenderer / bidder shall quote their rates **inclusive of GST**, as applicable after study the same and **GST** will not be paid / reimbursed by CONCOR.
12. GST, Building & other construction workers cess or any other tax, levies, duties on materials and on complete works in respect of this contract shall be payable by the contractor. CONCOR will not entertain any claim what so ever in this respect. This should be included in the rates quoted by contractor.
13. The contractor shall be required to pay cess @ 1% of cost of construction work in accordance with each bill payable on account of such construction to the **concerned State of Govt. (Labour Deptt.)**. Cost of material shall be outside the purview of cess, when supplied under a separate schedule items." CONCOR shall not entertain any claim whatsoever in this respect.
14. Insurances (i.e, Contractor All risk policy & Workmen Compensation Policy) for works, persons and property shall be taken by the contractor at his own cost for the entire duration of the project. Therefore, tenderer shall quote their rates inclusive of premium amounts of the Insurance Policies.
