EMD submitted in the form of Bank Guarantee should be received in original in the office of Group General Manager (P&S)/Area-2 before opening date and time of online e-bids mentioned in the above table. CONCOR shall not be responsible for any postal delay. The e-bids (tender) shall be opened in presence of the tenderers or their authorized representative, if they desire to attend.
 5. To participate in the e-bid submission, it is mandatory for the bidders to have user ID & password which has to be obtained by submitting an annual registration charge of INR 1180.00 (Inclusive of GST) to M/s ITI Ltd. through e-payment at the time of downloading/submission of e-bid.
